MONEY YIELDS EQUIPMENT; EQUIPMENT YIELDS RESULTS

The Partnership Fund **raised over \$500,000** during the 2008-09 fiscal year. **Parents donated over \$250,000**, including outright contributions, employer matching grants, and donations made through United Way/CFC. This past year, a generous TJ family made a four-year pledge to TJ of \$50,000!

The Partnership Fund helped TJ **purchase several major pieces of equipment** for the School's science and technology labs, including the latest significant acquisition, a circuit board plotter.

Cost: \$25,000. Value: Priceless.



Students in the Energy Systems Lab “populate” their circuit boards. Robotics, Optics, Energy Systems, Prototyping and Microelectronics Labs combined their fund requests in order to acquire this state-of-the-art circuit scribe. Before, students either had to fashion circuits by hand - a tedious and time-consuming process that used dangerous chemicals and yielded mixed results - or worked with breadboards that then had to be taken apart and reused by others. The circuit scribe has allowed students to fashion permanent, factory-quality circuits of their own design, freeing them to spend more time on the application.

WHAT WE DO:

Our Mission is to support TJ's educational programs, particularly those special programs that aim to fulfill TJ's overall mission as a science and technology school. The balance of this year's Partnership Fund grants helped the School acquire priority items from the science and technology labs' wish list. Over the years, the Partnership Fund has also supported various non-lab needs of the School, and donors are welcome to direct funds specifically to non-lab priorities.

The Fund approaches potential donors among parents, alumni, alumni parents, corporations and foundations. We act as a broker in forging long-term educational partnerships — as, for example, in the case of Lockheed Martin — and we facilitate and manage relationships that will be beneficial to our school.

Gifts to TJ include cash, contributions through United Way, and employer matching grants. The Partnership Fund also helps facilitate the purchase, delivery and maintenance of hardware, software, supplies, and equipment.
